SUBJECT: LEARNER ADMISSIONS IN PUBLIC SCHOOLS FOR 2022

1. This circular intend to provide guidance and directive to principals, admission committees and all departmental levels above the school. The school principal must ensure that the information contained in this circular and guidelines for 2022 admission in public schools must be provided to all parents, legal guardians and caregivers of Children of school going age.
2. **FUNDAMENTAL PRINCIPLES**
 - 2.1. The right of access to basic education and of equal access to educational institutions is not only enshrined in the Country's Constitution but has been taken forward in the **South African Schools Act (Act no 84 of 1996) as amended** and the **Gazette No. 19377 of October 1998 and National Circular No 1 of 2019.**
 - 2.2. This presents to all of us in the Province with enormous challenges, particularly in the context of our limited resources and vast needs. We have to rely on the commitment of all the role-players and stakeholders so that, together, we are effective in minimizing difficulties and speeding up transformation.

3. FIRST TIME ADMISSION

- 3.1. If your child is going to school for the first time, or moving to a new school, you must immediately collect registration forms from the school:-
- i. nearest to your home,
 - ii. within your feeder zone (Feeder zone refers to the geographical area from which the school admits learners. Learners attending in a primary school that falls within the feeder zone shall be considered to be coming from the feeder zone especially those in grade 7 moving to grade 8 within the feeder zone /area but their place of residence being elsewhere)
 - iii. where your other children (siblings) are attending,
 - iv. nearest to your work address,
 - v. of your choice.
- 3.2. Completed forms must be returned to the school by not later than **30th July 2021**. All Application forms are to be returned to schools according to the schedule developed by the school, based on the guidelines for 2022 learner admission in public schools. Admission for all categories will be treated on **a first- come, first-served basis**, assuming that all other criteria mentioned in the guidelines for 2022 admission are met.
- 3.3. All parents must insist on completing their details, in their own hand writing, in the **submission register for application forms** used to control new applications. The register will be used to determine who gets **first** preference, after other criteria have been used or considered.
NB: Parents must insist on being given the Application number
- 3.4. Provisioning of application number is not a guarantee that you will be allocated space, because first preference will be given to residents within feeder zone.
- 3.5. The school principal or the admission committee has the right to verify the information submitted, if it is discovered that the applicant applied through false information, with regard to residential area, such application shall be disqualified and be referred to the relevant feeder zones.
- 3.6. In order to comply with COVID-19 Health and Safety precautionary measures, the school must designate an area far away from classrooms, but within the school, where admission forms will be collected and submitted so as to avoid interaction of parents or members of the public with learners.
NB: Forms will be collected and submitted at the designated area determined by the school.
- 3.7. The designated area may be at the gate or an area wherein parents who are collecting and submitting forms are not in contact with learners and staff. Only the designated official administering the forms may have reasonable contact with parents, but such contact must be in compliance with Covid-19 precautionary measures.

- 3.8. Parents are urged to adhere to all Covid-19 protocols set at school in order to ensure that our learners and staff are safe.
- 3.9. Schools which are identified for on-line learner admission pilot project shall not distribute any form as admission will be done on line. Attached is a list of schools selected for on-line learner admission pilot project.
- 3.10. Parents who are unable to apply on-line will be assisted by circuit officials where-in the identified school is located.

4. AGE OF LEARNER

- 4.1. Schools admit learners from **Grade R-to-12**. In terms of the South African Schools Act, (**Act no 84 of 1996**) as amended a parent as defined by SASA may register his/her child at a school in terms of the following age requirement: .
 - i. **Grade RR: Three (3) years turning four (4) on 30th June 2022**
 - ii. **Grade R: four (4) years turning five (5) on 30th June 2022**
 - iii. **Grade 1 : five (5) years turning six (6) on 30th June 2022**
- 4.2. It is important to ensure that all eligible learners of compulsory school going age are accommodated in ordinary public schools Therefore, where space is limited and learners of pre-school going age have also applied for admission to an ordinary public school, preference must be given to learners of compulsory school going age as pronounced or determined in the South African Schools Act (**Act no 84 of 1996**)
- 4.3. It should be noted that In terms of paragraph 30 of admission policy for ordinary public schools in Notice number 2432 of 1998, GG 19377 the National Education Policy Act, learners who are in the school system, but who have become over-age because of repeating grades or other reasons, may not be refused continued education at a school..
- 4.4. Schools are directed not to develop their own age requirement except the once provided in paragraph 4.1.

5. ADMISSION REQUIREMENTS

5.1. DOCUMENTS REQUIRED

- a. In order to register your child you must bring the following documents with you:
 - i. **Birth certificate** or acceptable proof of birth date (do **not** take a **baptismal** certificate as proof)
 - ii. **Immunization** card
 - iii. **Transfer** card, and/or
 - iv. **Last report** card
- b. If you are **not** a South African **citizen**, you must also submit the following documents over and above the documents in paragraph 5.1.a. above:
 - v. **Study/work** permit

- vi. Temporary or permanent **Residence Permit** from the **South African Department of Home Affairs (DHA)**.
- vii. **Evidence** that you have **applied for permission** to stay in South Africa.

- c. If you do **not** have all or some of the above documents, you **may still** register your child at the school and the principal of the school **must advise** you where to get the required documents.

5.2. UNDOCUMENTED LEARNERS

- a. The constitution of the Republic of South Africa guarantees every person in the country to have access to basic education including learners without the following documents: birth certificate; immunization card; court placement order; study visa; permanent residence permit; asylum seekers visa; refugees visa; passport or identity documents which are required for admission
- b. It should be noted that as a department we have constitutional obligation to ensure that all compulsory school going learners have access to basic education
- c. Section 39 and 42 of the immigration act 13 of 2002 do not prohibit the admission of illegal foreign children into a school or prohibit the provisions of basic education to illegal foreigners
- d. When a parent applies for admission of a learner without birth certificate the parent must present a written affirmation or sworn written statement (in the form of an Affidavit) about the age of a learner to the principal of the school
- e. If the parent is unable to submit the birth certificate or has only submitted a written affirmation or sworn written statement about the age of a learner, the learner must be admitted
- f. The principal must advise the parents that section 31 of the Births and Deaths Registration Act, 1992 (Act No. 51 of 1992) makes it an offence to make a false statement or cause a false statement to be made about the age of a child.
- g. The school principal must assist the parents by referring them formally to the nearest office of the Department of Home Affairs to acquire birth certificates for their children

6. ADMISSION PROCEDURE (WHICH SCHOOLS SHALL FOLLOW)

- 6.1. The school at which you are registering your child **may not** ask you to:
 - i. Pay a **registration/admission** fee
 - ii. **Sign** an undertaking that you will pay the school fees as indicated.
 - iii. **Pay** some of the **school fees** straight away.
 - iv. **Sign** that you subscribe to the mission statement of the school.
 - v. **Agree** to the **Learner's Code of Conduct**.

- vi. Enter into a **contract** in terms of which the school will **not** be held accountable for damages arising during the education of your child.
 - vii. **Administer** a **test** before admitting your child.
- 6.2. You are **not obliged** to **agree** to any of the **conditions stated in paragraph 6.1 above** for your child to be admitted by the school.
 - 6.3. Your child **cannot** be **refused admission** at any public school nor denied access to cultural, sporting and social activities as a result of parent's **inability** to meet any of the above stated conditions.
 - 6.4. If you pay registration fees, you must insist that it be **credited** against your child's school fees.
 - 6.5. It should also be noted that **admission fee** is **outlawed**. The Department **SHALL** take **serious action** against those who act outside the provisions of the Act.
 - 6.6. The **administering** of tests for the sake of admission is **illegal**.
 - 6.7. The use of **pre-school experience** as a **requirement** for admission into Grade R or 1 is **against** the law.

7. **MAIN STEPS FOR ADMISSION**

- (a) Register your child at the school nearest to you from Wednesday, the 17th of May to Friday, the 30th of July 2021
- (b) Submit all the required documentation.
- (c) Obtain a waiting list number from the school.
- (d) By Tuesday, 31st August 2021 the school should have **informed** you **if** the application was **successful or not**.
- (e) If **unsuccessful**, you can **lodge** a complaint to your nearest Circuit Office.
- (f) It should be noted that feedback on whether the learner is admitted or not may be provided in July 2021, depending on the volume of the work administered by the school.
- (g) Registration of your child at selected schools participating on-line learner admission pilot project will commence from Wednesday, 26 May 2021 until 30th July 2021.
- (h) The system will guide parents on all the requirements.

8. **ISSUING AND RECEIPT OF APPLICATION FORMS**

- 8.1. In order to avoid stampede, application forms shall be allocated a period to be issued and submitted to schools according to grades.
- 8.2. Period of issuing and receipt of application forms is stated in the guidelines for 2022 admission

- 8.3. School Managers and Parents are urged to adhere to the guidelines in order to ensure that our communities are safe.
- 8.4. It should be noted that managers are advised to be flexible to cater for applications collected or submitted outside the dates stipulated in the guidelines.
- 8.5. Forms may be issued and received the same day, schools are expected to be ready to manage the two processes of issuing and receiving applications simultaneously.
- 8.6. Note that registration shall be opened from 17th May until 30th July 2021. Submission of application outside the targeted dates as reflected in guidelines may disadvantage the applicant however it will not be regarded as late application if submitted within the period of registration [from 10th May until 30th July 2021].
- 8.7. On-line learner admission pilot project shall be opened from the 26th May 2021 until 30th July 2021.

9. WAITING REGISTER

- 9.1. If you want your child to register to a school **away** from where you live, you **may** register your child at the school of your **choice**, BUT the school must put your child's name on a **waiting list**. The school must give you a **letter** to say that you are on the waiting list, and provide you a waiting list **number** or **position** on the waiting list.
- 9.2. The school must **inform** you by the **31st August 2021** whether your child is **accepted** at the school or **not**.
- 9.3. If you decide to **decline** admission offered at the school, you **must notify** the school as soon as possible. This will allow the school to give the space to another child.

10. RECOURSE IF NOT ADMITTED

- 10.1. If your application is not successful the school is obliged to provide written reasons why your child could not be admitted, as well as the address of the **Circuit Manager**, so that you can lodge an appeal in case you are not satisfied with reasons why your child could not be admitted or accepted. Your appeal will be **attended to within a period of ten working days**. attached is a sample of appeal register to be used when receiving appeals.
- 10.2. District and Circuits are urged to establish appeal register and **all submitted appeals** must be recorded according to submission dates and be attended in accordance to the directive or time frame given in the above paragraph 10.1.
- 10.3. If the appeal is not satisfactorily resolved, a parent or an applicant may lodge an appeal with the District Director, who must also resolve your case within **10 working days**.

- 10.4. If the **District Director** has **not** dealt with the appeal regarding an admission of your child to your **satisfaction** it is within your right to **refer** the matter to the office of the **Head of Department (through Institutional Governance Directorate), who will attend to it within a period of twenty [20] working days**
- 10.5. If you are **dissatisfied** with the response from the Head of Department you are advised to lodge an **Appeal** with the **MEC for Education**. The MEC will **respond** to your appeal within **21 working days**.
- 10.6. In all instances where you are taking your grievances to a higher office, it will be because the **lower** office has **not dealt** with the matter within the specified number of days or you are **not satisfied** with the response and the reasons given therefor.
- 10.7. While interacting with the Offices mentioned in the previous paragraphs, it is advisable to continue your search for admission at other schools in the area.
- 10.8. Parents who register for an appeal must provide details of their particulars, thus contact number and their residential address and work address.
- 10.9. **It should be noted that appeal will only be considered if is based on the incorrect or unfair application of the criteria set by the department of education**

11. PLACEMENT OF LEARNERS

- 11.1. The Department of Education has an **obligation** to **accommodate all** children of a compulsory **school-going age**.
- 11.2. As a way of ensuring that all learners of compulsory school going age are admitted, the department will ensure that learners are placed where spaces are available.
- 11.3. Schools shall submit a list of all learners who are not admitted to circuit office, the circuit shall facilitate the process of placement based on criteria outlined in the admission requirement, within a reasonable period.
- 11.4. If the Circuit office fails or is unable to place learners within the reasonable period, the District office shall take over the activity and facilitate placement of learners as a way of ensuring that all learners who are not admitted, are placed
- 11.5. The Provincial Office of Institutional Governance and Learner Support shall provide monitoring and support to the District in respect of the process of placement.
- 11.6. Reasonable steps will be taken to place learners nearer to their residential area, where possible.
- 11.7. Placement of Learners by circuit will commence from the 01st October until the 22nd October 2021 and shall be implemented from Circuit up to the level of Province.

12. RE-REGISTRATION OF LEARNERS FROM HOME EDUCATION

- 12.1. A parent who intend to re-register his/her child from Home Education into a Public Schools, must submit the following documents:
- (a) A registration letter with registration number permitting a learner to be registered in Home Education.
 - (b) Withdrawal letter from Home Education Programme, signed by the Head of Department or His Delegate
 - (c) The learner/s portfolio of evidence.
 - (d) Certified copies of annual assessment reports completed by competent assessor from when the learner was registered for home education to the last grade the learner completed at home education.
- 12.2. The District director must establish **Home Education Evaluation Team [HEET]** comprise Curriculum officials, Inclusive Education official, Institutional governance officials and circuit manager of the applied school. The team shall be co-chaired by Curriculum CES and District Institutional Governance Manager. Curriculum unit shall also provide secretariat function or support.
- 12.3. The decision the team shall be endorsed by the District Director and communicated to the parent.
- 12.4. The letter communicated to the parent must indicate his/her right to appeal to the Head of Department if the decision of District Director is contrary to the purported grade applied by the parent
- 12.5. The purpose of the HEET is to evaluate the submitted document and place the learner in appropriate grade

13. GRADE PLACEMENT ASSESSMENT TEST

- 13.1. Compulsory school going age learners who attended unregistered independent school and Home Education shall be placed in a public ordinary school, and be subjected to **GRADE PLACEMENT ASSESSMENT TEST** by the curriculum division in the department
- 13.2. Process of grade placement must take into consideration the age norm as outlined in paragraph 27 and 28 of admission policy for ordinary public schools in Notice number 2432 of 1998, GG 19377 the National Education Policy Act.
- 13.3. The District Governance unit must ensure that the learner from unregistered independent school is admitted as per advise from the curriculum unit which conducted grade placement assessment test
- 13.4. The district director must ensure that a police case is opened for a person operating an illegal or unregistered independent school, as the person would have violated section 46(1) of the South African Schools Act 84 of 1996 as amended.

13.5. No any circuit manager must allow unregistered school including learners attending Home education without being registered with the Provincial department, the intention is to protect learner's interest against inferior education.

14. PAYMENT OF SCHOOL FEES

14.1. Schools may charge school fees **except in No Fee Schools (Quintiles 1, 2, &3)** and parents/guardians are required to pay such fees. If you cannot afford to pay school fee, or can only pay part of the school fees, the school must still admit your child to the school.

14.2. **The principal must advise you on how to apply for an exemption from payment of school fees and avail the necessary forms.**

14.3. The onus to demonstrate **inability** or **limited ability** to pay school fees lies with the parent and it is the **responsibility** of the SGB to **verify whether** the parent qualifies for a **partial or full exemption**.

14.4. Please take note that a public school may by process of law enforce the payment of school fees by parents who are liable to pay

15. GRADE 12 REPEATERS and ADMISSIONS INTO GRADE 12

15.1. Please note that learners who **failed grade 12** or failed to meet pass requirement of their intended career are allowed to **repeat twice** i.e. they can do Matric **three times**.

15.2. The practice by some public secondary schools whereby learners who passed **Grade 11** at another school are **refused** admission into **Grade 12** or are **admitted** into **Grade 11** is **DISCRIMINATORY** and **UNLAWFUL**.

16. SPECIAL ADMISSIONS DURING THE YEAR

16.1. Principals must please take **note** that from time to time during the year the Department will place learners in their schools. These are learners **who due to circumstances beyond their control** and their **parents' control** or even beyond the control of the Department had to relocate from one place of abode to another.

17. OFFICIALS RESPONSIBLE FOR LEARNER ADMISSION

17.1. If your child is not admitted or placed, kindly consult with Circuit Manager or Assistant Directors for Governance of the Circuit where the school belongs, who will do everything possible to ensure that your child is appropriately placed.

17.2. At District level the following Governance Managers are responsible for the administration and management of learner admission:

18.4. We are making a clarion call to all affected parents to respond timeously and careful consider the stipulated timeframes in respect of registration of learners to avoid jumping onto the bandwagon of making accusations and counter accusations about things we could have avoided.

18.5. We, the Limpopo Department of Education, will **monitor** the situation **very closely** to **minimize** the occurrence of unfair discrimination.

18.6. We call on all the parents to **immediately go and register** their children for admission in terms of the procedure alluded to above in order to reduce the probability of conflict.


