#### ORDER

Having heard Counsel for the Applicants **ADVOCATE D J TALJAARD** and Counsel for the Respondents **ADVOCATE S A COLLETT** having read the papers filed of record and in terms of an undertaking furnished by the Respondents, duly represented by Mr **H M MWELI** and by agreement between the parties and in full and final settlement of the applications brought under Case No. **60/2011** and **214/2011**.

### IT IS ORDERED THAT:

- 1. The Respondents shall:
  - 1.1 In terms of the prescripts of the prevailing legislation, determine the 2010 post establishment for educators in the Eastern Cape Province;
  - declare and communicate to the schools such post establishment by the 30<sup>th</sup> September 2011;
  - 1.3 advertise such declared posts by:
    - 1.3.1 31<sup>st</sup> October 2011 in respect of the post level 1 Educators;
    - 1.3.2 30<sup>th</sup> November 2011 in respect of the Head of Departments and Deputy Principals;
    - 1.3.3 31<sup>st</sup> December 2011 in respect of School Principals;

- fill all declared posts in terms of the 2012 Post Establishment by 31<sup>st</sup> January 2012;
- 1.5 fill all vacant substantive posts in terms of the 2010 Post Establishment on a temporary basis pending the implementation of the 2012 Post Establishment, provided that where the learners numbers have decreased in a specific school, temporary educators will be appointed in terms of the 1:34 National ratio to such schools pending the implementation of the 2012 Post Establishment 30 days from this order;
- 1.6 the Review Application under Case No. 60/2011 is hereby withdrawn and the *rule nisi* granted in terms thereof shall lapse with effect from 30 days of this order;
- 1.7 The Respondents will pay the costs duly taxed jointly and severally in respect of this application and the application under 60/2011 as at today's date.
